

Privacy Statement Study Association AIM

1. Who are we?

- 1.1 We are Vereniging AIM, the study association for students of the Politics, Psychology, Law and Economics programme at the University of Amsterdam. Vereniging AIM is located at Roetersstraat 11-E1.17 1018 WB Amsterdam.
- 1.2 Vereniging AIM (hereafter: Study Association AIM) is registered at the Commercial Register at the Dutch Chamber of Commerce (Kamer van Koophandel) under number 62383981.
- 1.3 This privacy policy outlines what personal data Study Association AIM processes, to what end and how this data is used and protected.

2. Technical data

- 2.1 When you visit our website (aimpple.nl), it automatically collects non-personally identifiable data about the (devices) of our visitors.
- 2.2 This data collection includes e.g. the IP-address of your device or Internet Service Provider, the date of your visit and the pages on our website you visited.
- 2.3 We use this technical data to manage our website and to improve the quality and effectiveness of our website.

3. When do we collect your personal data?

- 3.1 In the following cases, Study Association AIM is allowed to store and process your personal data:
 - a. When you have given consent to the processing of your personal data for one or more specific purposes;
 - b. When processing is necessary for the performance of a contract to which you are a party or in order to take steps at your request prior to entering into a contract;
 - c. When processing is necessary for compliance with a legal obligation to which Study Association AIM is subject;
 - d. When processing is necessary in order to protect your vital interests or those of another natural person;
 - e. When processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in Study Association AIM;
 - f. When processing is necessary for the purposes of the legitimate interests pursued by Study Association AIM or by a third party, except where such interests are overridden by your interests or fundamental rights and freedoms which require protection of personal data.

4. Why do we collect your personal data?

- 4.1 Study Association AIM collects your personal data in order to:
 - a. Process your membership subscription;

- b. Process the automatic membership renewal;
- c. Process your orders in the AIM webshop;
- d. Send you our newsletter and member emails;
- e. Process your AIM purchases through the Athenaeum webshop;
- f. Share our membership list with the University of Amsterdam.

5. What personal data do we collect?

5.1 For your membership subscription, we process the following personal data:

- a. First and last name;
- b. Student number;
- c. Email address;
- d. Year of enrollment in PPLE College at the University of Amsterdam;
- e. Address, postal code, city and country;
- f. IBAN and BIC.

5.2 For your webshop purchases, we process the following personal data:

- a. First and last name;
- b. Phone number (optional);
- c. Email address;
- d. Address, postal code, city and country;
- e. Payment method;
- f. Order history;
- g. IBAN, BIC and/or partial credit card details.

5.3 For our newsletter and member emails, we process the following personal data:

- a. First and last name;
- b. Email address;
- c. Subscriber activity history.

5.4 For your AIM purchases through the Athenaeum webshop, we process the following personal data:

- a. First and last name;
- b. AIM orders through Athenaeum.

6. Third parties

6.1 To perform our services, Study Association AIM shares certain personal data with third parties, as described below.

6.2 With ING Bank N.V., we share the following personal data:

- a. First and last name;
- b. IBAN and BIC.

6.3 With the University of Amsterdam, we share the following personal data:

- a. First and last name;
- b. Student number.

6.4 With Mailchimp, we share the following personal data:

- a. First and last name;

b. Email address.

6.5 With Congressus, We share the following personal data:

- a. First and last name;
- b. Email address;
- c. Student number;
- d. IBAN and BIC.

7. Data storage

7.1 Study Association AIM will delete your personal information as soon as possible after it has served its purpose, as outlined above.

7.2 Your personal data will be stored for at least the duration of your membership.

7.3 Upon your request, your personal data can be removed from our data storage at any point in time.

8. Information, modification, objection and removal

8.1 You can reach out to Study Association AIM through info@aimpple.nl for:

- a. More information about the way Study Association AIM processes personal data;
- b. Questions arising from this privacy policy;
- c. Insight into the personal data that pertains to you that Study Association AIM processes;
- d. Objections against the use of your personal data by Study Association AIM;
- e. Modification or correction of your personal data as collected by Study Association AIM;
- f. Removal of your personal data from Study Association AIM's data storage.

8.2 We will try to comply to the aforementioned requests (see 8.1) as soon as possible, but at the latest a month after the request has been submitted.

8.3. We are obligated to check your identity before complying to the aforementioned requests regarding your personal data (see 8.1).

9. Report to Dutch Data Protection Authority (Autoriteit Persoonsgegevens)

9.1 When, despite our security measures, we experience a security breach, and this breach has (possibly) substantially severe adverse consequences for the protection of your personal information, this will be reported to the Dutch Data Protection Authority.

10. Report to the person involved

10.1 You will be notified in case of a breach of our security when the breach probably has adverse consequences for your personal life sphere.

11. Modification of the privacy policy

11.1 It is possible that the policy enshrined in this privacy policy is modified in the future. We therefore recommend you to look at our privacy policy regularly.
